By my printed name and signature below, my participation or entrance into the event or admittance to any area wherein admittance to the general public is prohibited, I agree to release and hold harmless for any accidents, injury or illness that may occur or may be alleged in the future to of have occurred on the above date as a result of either my, my minor child's or my legal ward's participation in, assistance in, or as a spectator during the course of the above named event and related or unrelated activity being conducted by above named sponsor or event sponsor.

To the best of my knowledge, I am not aware of any physical disability or health-related reasons or problems which would preclude or restrict my, my child's or my legal ward's participation in this activity. I am fully aware of the risks and hazards connected with the above named event and that there may be other unknown risks and I hereby elect to participate in, or allow my child's or my legal ward's voluntary participation in said activity, knowing that the activity may be hazardous to me, my minor child, my legal ward or my property. I agree to indemnify and hold harmless the above named sponsor or promoters, its trustees, officers, agents, officials, employees or volunteers, from any loss, liability, damage or costs, including court costs and attorneys' fees that may be incurred, due to my, my minor child or my legal wards participation in the above named event and related or unrelated activity.

It is my express intent that this Release, Waiver of Liability and Indemnity Agreement shall bind my family, if I am alive; and my heirs, assigns and personal representative, if I am deceased; and shall be deemed as a release, waiver, discharge and covenant not to sue the above named sponsor or promoters, its trustees, officers, agents, officials, employees or volunteers. I hereby further agree that this Release, Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the Commonwealth of Pennsylvania and that any claim and any subsequent legal filing or action shall be made in the Court of Common Pleas of the county in which the event is located and be tendered by a non-jury trial. Said County Court of Common Pleas shall have exclusive jurisdiction and venue to resolve any such claims.
